- 4. Tender Document: Tender document can be obtained by downloading it from the website <u>http://www.eprocure.gov.in</u>.
 - 4(i) Tender fee of Rs. 200/- may be submitted separately (at the time of submission of EMD) in the form of DD from any nationalized bank payable at Chennai in favour of Accounts Officer (Cash), O/o PCCA, Tamil Nadu Circle, Chennai. Exemption for cost of tender/ tender fee will be allowed to the eligible bidders as per the extant rules of Govt. of India on the subject. To claim exemption, supporting documents should be provided.
 - 5. Sale of physical copy of tender Document: Not applicable [process of e-tendering for inviting this tender is adapted and thus the physical copy of the tender would not be sold]
 - 6. Submission of tenders: Tenders have to be submitted online only at https:// eprocure.gov.in/ eprocure / app in two bid systems i.e. (i) technical bid and (ii) financial bid in the prescribed proforma. The downloaded NIeT documents(Part A and Part B) additionally etc. are to be submitted in hard copies in sealed cover along with DDs for EMD & Tender fee on or before the last date & time for submission of e-Tender as specified in para 3 Time Schedule above in the tender box at the Column 6 of para 3 Time Schedule.
 - 7. EMD of Rs.40,000 (Rs.Forty thousand only) in the form of DD from any nationalized bank payable at Chennai in favour of Accounts Officer (Cash), O/o PCCA, Tamil Nadu Circle, Chennai has to be submitted by the participating tenderers. The DD has to be submitted offline before 1500 hrs on 11-12-2018 as mentioned in para 6 above. Exemption for EMD will be allowed to the eligible bidders as per the extant rules of Govt. of India on the subject. To claim exemption, supporting documents should be provided.
 - 8. The Department reserves the right to amend or withdraw any of the terms and conditions contained in the Tender Document or to reject any or all tenders without assigning any reason. The decision of the PCCA, Tamil Nadu Circle, Chennai, Ministry of Communications, Department of Telecommunications in this regard shall be final and binding on all.
